The Resource Recovery Coalition of California (Resource Coalition) was originally established in 1953 as the California Refuse Recycling Council by several independent refuse associations from Northern and Southern California. These associations united for the first time to oppose state legislation that threatened to impose substantial costs on the waste industry, potentially reaching hundreds of thousands of dollars statewide. Following a successful campaign to secure an exemption from this transportation legislation, these groups continued their collaboration, laying the foundation for what is now the Resource Coalition.

Over the years, both the industry and our association have evolved to meet the demands of a changing landscape. Yet despite these changes, our **CORE OBJECTIVES** have remained the same:

- To promote the general welfare and business interests of our members
- To encourage the highest standards of ethical business practices among our members in the public interest
- To work for the benefit and the fostering of goodwill for the members of the waste management industry throughout the State of California and the State of Nevada
- To afford to all agencies of government on the federal, state, county and city levels a means of cooperation and coordinated effort to the most efficient and economic standard of collection, disposal and recycling of refuse materials
- To foster and further the American principle of free enterprise and competition

Legislative and Regulatory Representation

The Resource Coalition maintains strong representation in Sacramento, effectively advocating for the interests of the waste and recycling industry on critical issues. Executive Director Veronica Pardo, in partnership with contract lobbyist Lindsay Gullahorn of Capitol Advocacy, serve as the Resource Coalition's key representatives at all relevant regulatory and legislative hearings. She also plays a vital role in shaping the Resource Coalition's engagement strategies with lawmakers and legislative staff, reinforcing our reputation as a trusted authority and leader on waste and recycling matters.

Together, Veronica and Lindsay provide comprehensive representation across a wide range of regulatory bodies, including CalRecycle, the California Air Resources Board, the California Energy Commission, the State Water Resources Control Board, the Department of Toxic Substances Control, Cal/OSHA, and other key agencies.

Our government affairs team ensures that the needs and priorities of Resource Coalition members are thoroughly considered in the development of California policies that directly impact the waste and recycling industry.

Federal Activities

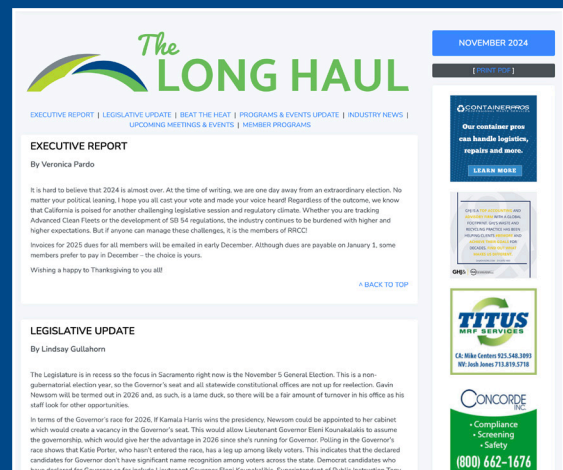

The Resource Coalition's By-laws outline the membership application process. All new members must be approved by a majority vote of the Board of Directors. Each application should identify a qualified Industry Member sponsor.

Dues for Industry Members are based on either the residential population of their service area or their gross income, and are invoiced annually in December.

The Board of Directors reviews all membership applications in accordance with the By-laws, which require applications to be presented and read at two consecutive Board meetings. A vote is held after the second reading to determine approval.
